





In order to efficiently perform all probation tasks, special attention in communication must be the identification of all potential stakeholders and partners in the community and the design of the protocols of cooperation




Communication with partners

Probation Service cooperates and exchanges information with the courts, prosecution, police, prison system, NGO's, institutions of the health and social welfare, educational institutions, employment service and all other organizations that are relevant

for probation tasks and offenders
