
# Development of probation service in Croatia



## Internal organisation of Probation Service


























# Probation tasks in different stages of Criminal Process

PRE-TRIAL Pre-trial reports (public prosecutor) Supervision of obligations (public prosecutor)	CRIMINAL TRIAL Pre-sentence reports to the Court for decision-making
EXECUTION OF CRIMINAL SANCTIONS	EXECUTION OF THE PRISON SENTENCE
(ENFORCEMENT PHASE)	Reports for courts, prisons or penitentiaries
Community work	Protective supervision during conditional
Suspended sentence with protective	release/upon the end of the prison sentence
supervision, special obligations or security	Supervision of prisoners while using
measures	temporary release

#### Mental Health Care in Probation

#### Mandatory Psychiatric Treatment (čl. 69 KZ)

Security Measure Uttered with suspended /partial suspended sentence, community work or conditional release

Expert opinion needed

#### Mental Health Care in Probation

Treatment or continuation of treatment that is necessery for the elimination of health disorders that can stimulate the commission of a new criminal offense (čl. 62.st.2.t.4. KZ)

Special obligation

Uttered with suspended /partial suspended sentence, community work or conditional release Voluntary consent

#### Mental Health Care in Probation

#### Who else:

Offenders without mandatory treatment

Assessment of the probation officer Motivation and a relationship based on trust with the offender is crutial







## Treatment Facilities in Zagreb





#### Availability of Services in other parts of Croatia



#### Difficulties

- unavailability of a psychiatrist
- no network of treatment facilities
- pharmacotherapy only
- superficial treatment



#### Outcomes

- Offenders with severe mental problem see a specialist maybe every 3-4 months
- Offenders have high financial costs
- Motivation for treatment is low

## Special program for sexual offenders "Mirror"



- sexual offenders also recieve SM of SO
- There is only one psychiatrist specialized in working with sex offenders in Croatia
- 2017- a few Probation Officers finished an education within the Twinnig project (Mirror)
- Idea- every Probation Office has an educated expert
- Based on basic models of working with the offenders (RNR model, Good Living Model) and specific models for sexual violence


## Special program for sexual offenders "Mirror"


Program Content




- Intended for group work
- Interactive
  - Topics: sensing and regulation of emotions, social competences, self image, communication skills, stress menagement, empathy, victim awareness, cognitive distortions, sexual fantasies
- Consists of 3 phases:
  - assessment and motivation (3-4 meetings)
  - intervention (24 meetings)
  - Follow up (1-2 meetings)









# Challenges in working with offenders with mental health problems



- Taking therapy irregulary unavailable for any treatmants or interventions
- Distrust of the offenders due to their mental illness
- The offender represents a risk for himself and his family members
- The imposed sanctions are not in accordance with their capabilities and limitations
- The treatment system is based on voluntariness-no insight into their behaviour
- Family members represent a protective and a risk factor
- Insufficient education of probation officers for working with offenders with mental problems
- Insufficient communication between a probation officer and a specialist
- No response from the court when needed

## Example of good practice

"Specifics in working with people with mental and bihevioral disorders"



- Training intended for probation officers
- Goal educate probation officers of the right way of working, behaving and communicating with the offenders who have mental health problems
- Lecture, workshops (group work, role playing discussion and evaluation

# "Specifics in working with people with mental and bihevioral disorders"

- organized due to enthusiasm and effort of a few colleagues and psychiatrists from Clinic for Psychiatry Vrapče, Zagreb
- without compensation for lectures
- Idea acquire and expand knowledge in psychiatry in order to individualize our approach to offenders
- Goal more efficient treatment, respecting the possibilities and limitations of people with mental disorders

The training was organized only for offices around Zagreb area and not all probation officers had the oportunity to pariticipate













## Conclusion:

- Significant increase in the number of mentally ill offenders in Croatian Probation Service during the years
- Insufficient education of probation officers for working with offenders with mental problems in Croatian Probation Service
- no network of treatment facilities in some parts of Croatia
- sanctions are not in accordance with the capabilities and limitions of the offender
